SECTION 4: First aid measures

• General information:

Symptoms of poisoning may even occur after several hours; therefore medical observation for at least 48 hours after the accident.

• After inhalation:

Supply fresh air. If required, provide artificial respiration. Keep patient warm. Consult doctor if symptoms persist.

• After skin contact: Immediately wash with water and soap and rinse thoroughly.

• After eye contact:

Wash eyes immediately with a large amount of water or normal saline, occasionally lifting upper and lower eye lids until no evidence of chemical remains (about 20 minutes). Remove contact lenses if present and easy to remove. Seek immediate medical attention.

• After swallowing: If symptoms persist consult doctor.
